- o Orientalism

Definition: "Trademark antiques, attributes, or styles of Asian societies and individuals" and "stereotypic Asian portrayal considered as representing the mentalities of colonialists"².

Europeans outlined themselves to be the more fabulous race and remembered their obligation to achieve progress in savage social orders, the conspicuous approval for imperialism. In 1978, from Columbia University, Prof. Edward Said expressed in his driving book named "Orientalism" that Orientalist researchers which were essentially Anglo-Americans depicted individuals of "The East" as the colorful "Others". Additionally, they alluded Eastern individuals to be significantly different from and inadequate when contrasted with Western human advancement, displaying them as on a very basic level silly, authoritarian, crude, fan, and rough. The provincial undertaking of Europe was defended by these portrayals by making these societies and Muslim people group to be a danger to Western individuals and human advancement³.
